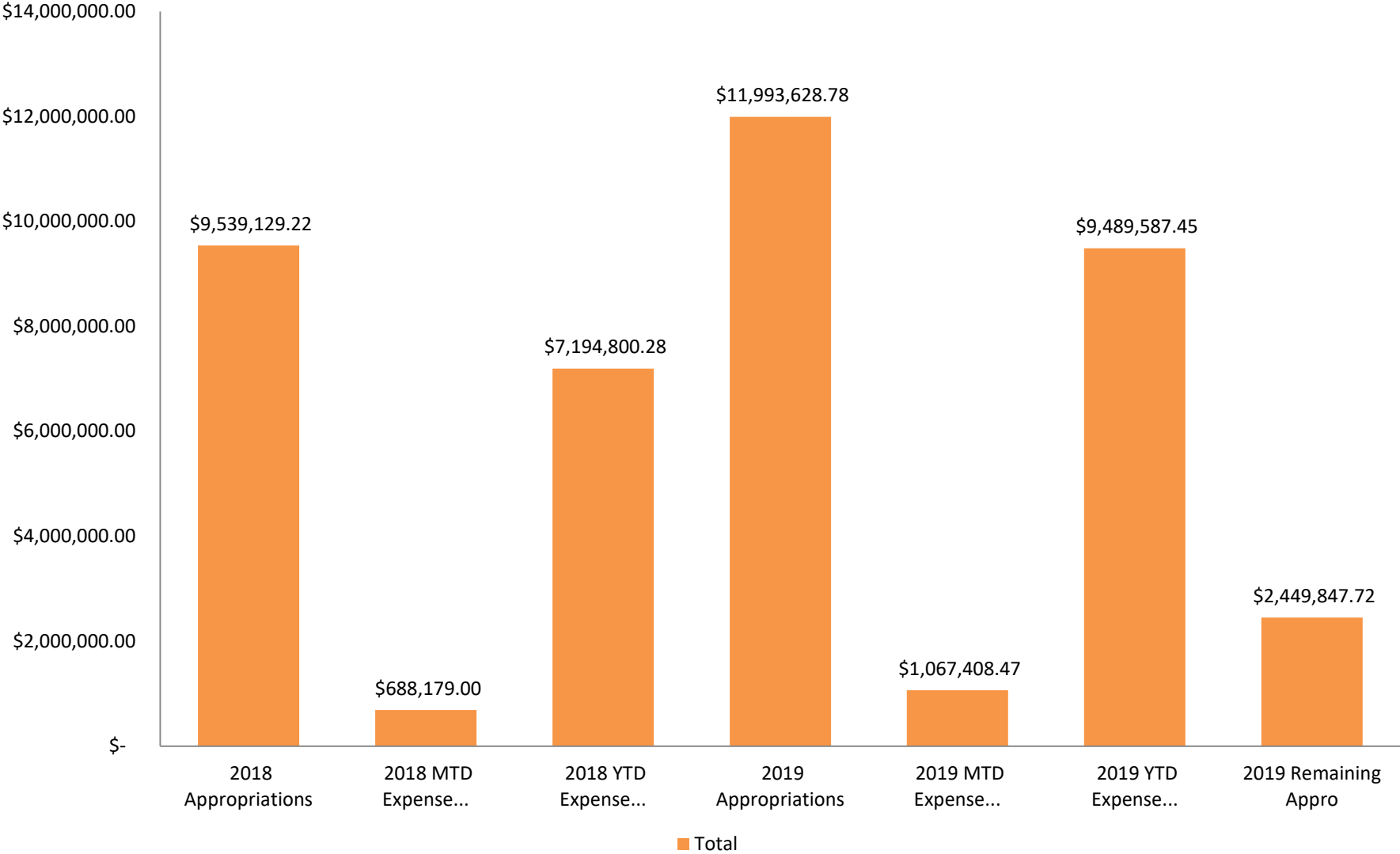

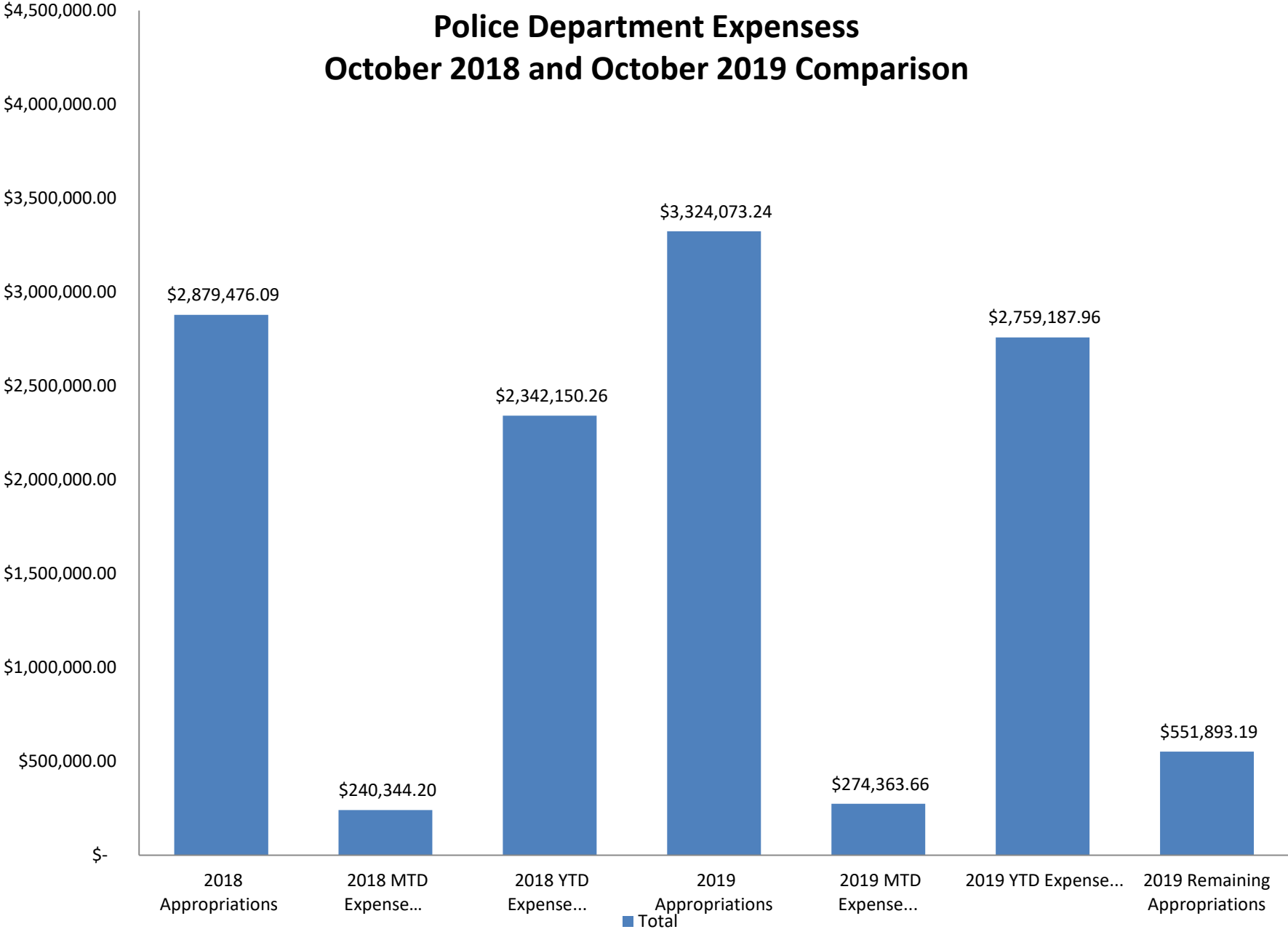

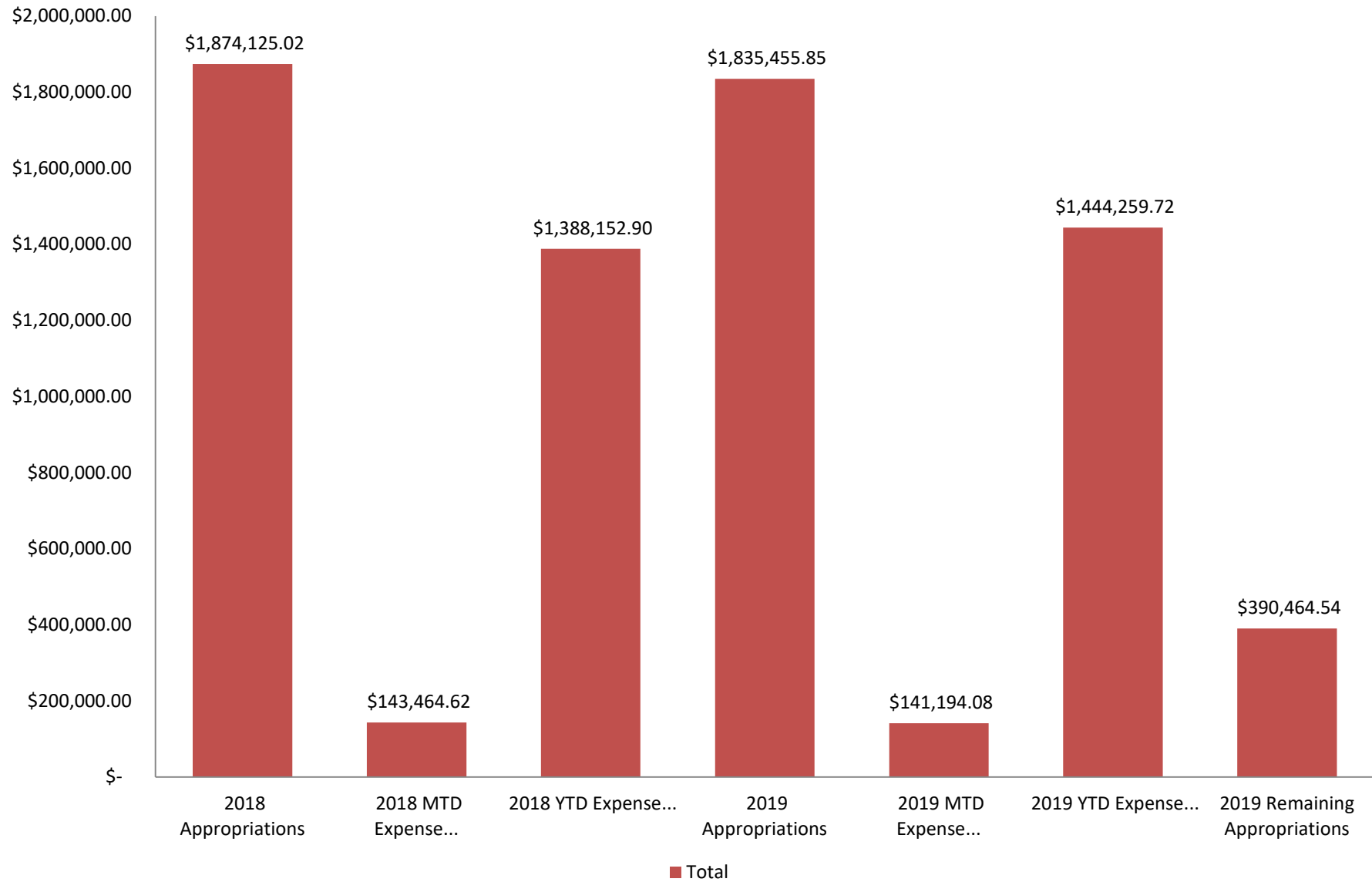

## Police Department Expenses October 2018 and October 2019 Comparison

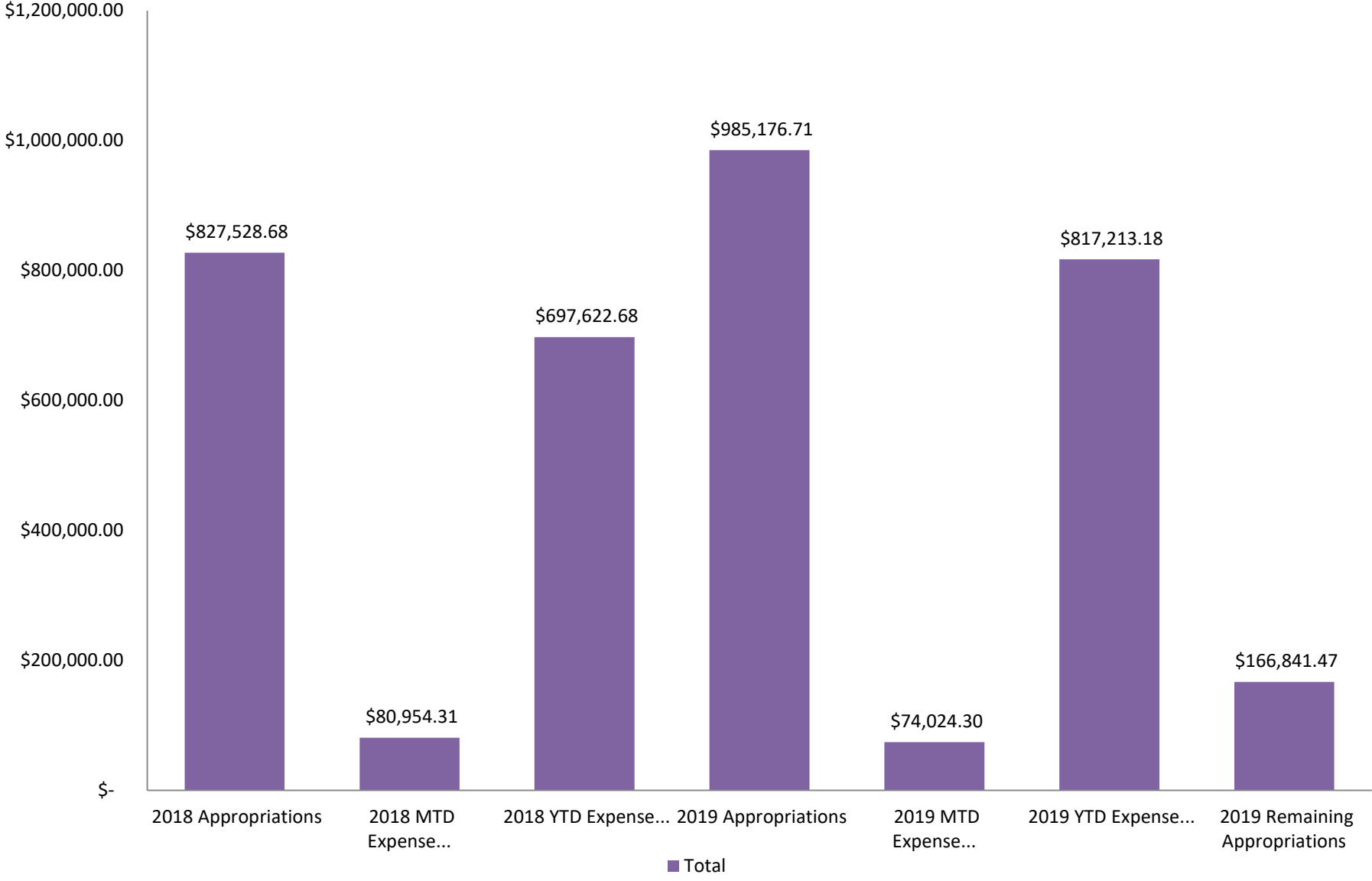


## Fire Department Expenses October 2018 and October 2019 Comparison
